#### **TREASURER'S REPORT – DOUG LONGSON**

This has been a good year for the Friends, financially.

Earnings from the Stockman's Banguet & silent auction set another new record. Combined with the revenue from the Trail Ride, memberships, and our calf crop, there was sufficient income to meet our operating costs.

This year, the Casino proceeds were used to purchase an arena rake, and harrows, to upgrade the Pierson House interior (cedar paneling, and painting), and also to roof, and paint the adjoining buildings.

The next casino will be held in the first quarter of 2012.

A grant was received from the Alberta Community Spirit Program, and was used to pay our insurance costs, and to purchase a boardroom table for the Pierson House.

Income from the Bar U Legacy Fund was used to purchase prizes for the Ranch Rodeo, and to purchase new tires for the wagon used on the trail ride.

Special thanks to Maxine Nelson & Carole Hergert– Friends; Rose Dayment - Payroll; Liz Hergert bookkeeping; and Stephen Muth - accounting.

Thank you Parks Canada for allowing us to use the Pierson House as our office. And all the staff for mowing, shoveling, and other maintenance.

### ALBERTA COMMUNITY SPIRIT GRANT PROGRAM

We received a grant of \$4,225 this year - this amount matches \$ for \$, the donations we received to the Bar U Legacy Fund, at the annual Stockman's Dinner (\$14 donation eligible for a tax receipt), and the annual Trail Ride (\$45 donation eligible for a tax receipt).

Great News for donors!

The charitable tax credit applies to Canada Revenue Agency-registered charities such as the Friends of the Bar U, which is eligible to issue official income tax receipts.

Including the federal tax credit, you now receive a 50-cent non-refundable tax credit for every dollar donated over \$200.

For example, if you donate a total of \$500 to four or five charities throughout the year, you would receive a combined federal and provincial charitable tax credit of \$200. This means that the donations would cost you about \$300, which is the equivalent of donating 82 cents a day.

### **CATTLE REPORT**

We had a good calf crop thanks to Ken and Jim. Due to the cold spring we did not buy yearlings. We got 45 head from DK Livestock at Longview and used them for two events. We sold the calves in early October.


#### COLLECTIONS

### Site Manager's Message – Ken Pigeon- Parks Canada Bar U

On behalf of Parks Canada Agency I am pleased to provide a report summarizing our work at the Bar U Ranch National Historic Site. The diversity of projects and programs undertaken reflects the commitment to the ranch by both our volunteers and staff. Facilitating exceptional visitor experiences at the ranch have lifted the Bar U to the status of a flagship National Historic Site.

In 2010 Parks Canada celebrated the 125<sup>th</sup> anniversary of the founding of Banff National Park and in 2011 Parks Canada will be celebrating the 100<sup>th</sup> year of the Dominion Parks Service, the first National Park Service in the world.

This year we completed a Visitor Exit Survey and a Visitor Experience Assessment. Both exercises provided us with important information on what's working and what needs to be addressed to help us remain relevant and real to our visitors.

In 2010 the Bar U Ranch management plan came up for its five year review. Parks Canada legislation requires that management plans be reviewed every five years by the minister for all protected heritage places and that any amendments be tabled in parliament. To this end the site has decided that the current direction of the 2005 management plan is still valid and working therefore, we have submitted a State of Site Report and Scoping Document along with a briefing note to the CEO of Parks Canada recommending that no amendments to the current plan are required at this time.

While visitation is stable, the key goal over the next five years is to increase visitation numbers specifically from the Calgary market. To help with this a five year marketing plan will be completed this winter. To increase awareness in Calgary the Bar U was involved in several activities and events throughout 2010 which included Aggie Days, Spruce Meadows, Outdoor Adventure Show and Calgary Stampede. The site participated in a new venue at the Calgary Stampede called Draft Horse Town which was a great success and we plan to participate again next year.

Among volunteers there are no ordinary people....... To all our Friends and volunteers I wish to say thank-you. For without your time and energy it would not be possible to accomplish what we do.

Now I would like to leave you with this quote from Conrad K Warren: "With our heritage of grass and water, shade and shelter being among the richest endowments of all men, let us therefore preserve and keep it for ourselves and our heirs so that it will forever endure and be a continuing benefit to all mankind."

## 125<sup>TH</sup> ANNIVERSARY BAR U LEGACY FUND

The Bar U Legacy Fund is an endowment fund managed for us by The Calgary Foundation. The **income** from this fund will be used to support the Heritage Ranch Rodeo (prizes, advertising) - our main event - which showcases historical ranching practices.

An endowment fund is a registered fund that never spends the capital contribution, but generates income through investments. Annually, a percentage of the income is distributed to the **Friends**, and the balance is re-invested in the fund. This way the fund continues to grow, and the gift keeps on giving in greater amounts every year.

The fund, currently in excess of \$16,000 is managed by The Calgary Foundation, a non-profit foundation which currently manages over 100 funds for charitable organizations. This ensures that only the income will be available to the **Friends**; there will **never** be access to the capital in the fund.
